

### **YOUR STEWARDSHIP IN ACTION**

Your support makes a difference in the lives of the individuals and families Mercy Housing and Shelter Corporation serves. Here are some of the ways you helped during the 2022 fiscal year:



In partnership with other Greater Hartford Coordinated Access Network agencies, Mercy Homeless Diversion staff kept 4 out of 5 families in a housing crisis out of sheltér.

### Other Accomplishments:

- Mercy purchased and renovated a former convent to provide a 24-hour residential program for young adults aging out of the foster care system and at risk of homelessness to help them gain skills to live independently.
  Mercy was able to expand its services in Middlesex County through a contract from the Town of Portland. The program served 209 participants from Nevember 2021 to lung 20, 2022.

### THE PERSEVERANCE OF DORIAN

Applying for a job requires a lot of resources: an address, a phone number, a computer, an educational background, and a work history. If one or more of these resources isn't available, the possibility of obtaining employment diminishes. These obstacles are ones individuals at Mercy Housing and Shelter Corporation work to overcome every day.

Meet Dorian, a participant in Mercy's Permanent Supportive Housing Program who began working with our employment specialist Karen in early 2020. Prior to the COVID-19 pandemic, Karen helped Dorian enroll at Capital Community College, assisting him with setting up a Gmail account and applying for financial aid. When his courses shifted online due to the pandemic, Karen helped Dorian access a program providing free internet to low-income households. Switching to online learning in 2020 was challenging for kids and adults alike, but Dorian's limited computer experience made his college courses even more difficult. His perseverance won out, and he passed all of his classes.



Karen then provided Dorian with information about the Best Chance Program, a free pre-manufacturing and job placement assistance program at Manchester Community College. Dorian met the admission requirements and entered the program in March 2021. With his hard work, he completed the program in three months!

Upon graduating, Dorian returned to Karen for assistance with his job search. Karen helped Dorian practice interview questions and secure an appropriate outfit for the occasion. With Dorian's persistence, and Karen's assistance, Dorian was hired at FHI; a supply-chain solutions company in Manchester, CT. He recently celebrated his one year anniversary with the company.



### SUPPORTING THE COMMUNITY

As Hartford emerged from the pandemic, Mercy Housing and Shelter Corporation held several inevents person to support individuals in need throughout the city. Mercy held multiple clothing giveaway days at St. Elizabeth House, and partnered with its sister organization, My Sisters' Place, to host a job fair. These events provided a much-needed resource for those served, and contributed making Hartford a thriving to community to work, live and play.






