YOUR STEWARDSHIP IN ACTION

Your support makes a difference in the lives of the individuals and families My Sisters' Place serves. Here are some of the ways you helped during the 2023 fiscal year:



191 households in Greater Hartford were assisted with permanent supportive housing and residential supports, helping them have a place to call home.



278 households in Greater Hartford were provided with rental and security deposit assistance to ensure they could achieve safe and stable housing.



73 children were provided with supports through our youth education and enrichment program:

- 51 children participated in social and enrichment activities
- 27 children participated in tutoring

All had access to basic needs, such as clothes, food, and referrals for behavioral healthcare.



54 households served by our Housing Mobility Program were able to move to thriving communities.

IF WALLS COULD TALK

If the walls of 102 Pliny Street could talk, they have the feeling they would tell you a long and captivating history of supporting those coming out of homelessness. Once a factory, 102 Pliny Street was renovated into 18 apartments to hold My Sisters' Place's Transitional Living Program, which opened in 1991. The program served women and their children, who could live in a one-to-four bedroom unit for up to two years. During that time, they received services such as life skills programs, education, support groups and case management.

The walls of 102 Pliny Street would share 26 years of success stories from those who walked through its doors. They would range from women who found the opportunity to continue their education and subsequently gained steady employment, to children improving their social skills and building friendships with others. New journeys would begin as individuals and families moved in and out of 102 Pliny Street, thus adding to the legacy of the building.

The walls of 102 Pliny Street would be silent for a time. The Transitional Living Program ended in April 2017 and the building lay dormant for six years. Depression and disrepair occupied the space where hope and confidence was once renewed. Fortunately, in 2022 My Sisters' Place received the funds to renovate 102 Pliny Street into 24 new units of affordable and supportive housing. There would be new life for a building that had helped thousands realize their lives could change for the better!

If the walls of 102 Pliny Street could talk now, they would be brimming with excitement. Throughout 2023, the building has been gutted and renovated. A ceremonial groundbreaking was held in June 2023 to celebrate this momentous occasion. Soon, 102 Pliny Street will welcome new individuals and families who have experienced homelessness; much like it did 32 years ago. We can't wait to see how their stories will unfold.








